

Wilton Public and Gregg Free Library  
Trustee Board Public Meeting Minutes  
October 17, 2025

The meeting was called to order at 8:00 a.m. at the Wilton Public and Gregg Free Library. Attending were trustees Allison Meltzer, Ron Brown, Lynne Stone, Bill Langille, Nikki Andrews, and Mark Worcester, and alternate trustee Nancy Elcock. Joe Torre attended on behalf of the town Budget Committee. Library Director Arefe Koushki joined the meeting at 8:20. Trustee Arlene Laurenitis and alternate trustee Bill Ryan were absent.
